III Execution of the Agreement

The specific activities to be carried out under this agreement will be stated in corresponding specific sub-agreements. Such specific sub-agreements, once approved by all the parties, will be attached as annexure to this agreement. The specific sub-agreements among all the Parties will specify their objectives, conditions and ways of execution, financial support, period the sub-agreement will be in effect, and administrative responsibility within each institution.

IV. Term and Expiration of the Agreement

It is understood that this agreement will come into effect after being signed by the two parties and will be established for a period of five years. After these five years it will be automatically extended for same period, unless one of the Parties expresses an intention (by written notification) to cancel the agreement at last 90 days before the expiry date. The amendment, termination and expiration of this MOU will not affect the terms of activities ongoing at the time of notification of amendment, termination or expiration, unless otherwise agreed upon among the parties.

Any additions, changes, or deletions to this document must be approved by the representatives of both Parties. All notices shall be in writing and shall be directed to these representatives.

Non-Exclusivity
